In consideration of the International Heart Journal Association reviewing and editing the above described work for first publication on an exclusive basis.

The undersigned author hereby assigns, conveys, and otherwise transfers all rights, title, interest, and copyright ownership in said work to the International Heart Journal Association effective upon acceptance of said work for publication. "Work" includes the material submitted for publication and any other related material submitted to the International Heart Journal Association.

The assignment of rights to the International Heart Journal Association includes but is not expressly limited to rights to edit, publish, reproduce, distribute copies, prepare derivative works, include in indexes or search databases in print, electronic, or other media, whether or not in use at the time of execution of this agreement, and claim copyright in said work throughout the world for the full duration of the copyright and any renewals or extensions thereof.

All accepted works become the property of the International Heart Journal Association and may not be published elsewhere without prior written permission from the International Heart Journal Association. Authors may use parts of the work (eg, tables, figures) in subsequent works without requesting permission from the International Heart Journal Association.

For Works created under grant from a funding body and accepted for publication in the International Heart Journal, the author may cause the posting of the "Accepted Version" of the Work on the web-based archive of a funding body responsible for the funding in whole or part of the Work, provided that the posting is no sooner than 6 months after publication of the Work in the International Heart Journal and that the archive is publicly available via the World Wide Web in a noncommercial manner.
